

ICEL Report 2022-2023

To the Bishops in countries where English is used in the Sacred Liturgy:

The International Commission on English in the Liturgy was established in October 1963 as an unincorporated association of Bishops designated by the sponsoring Conferences of Bishops. In 1967 the Commission was incorporated in Canada for religious, charitable, and educational purposes. Between 2008 and 2013 ICEL transitioned to a not-for-profit firm, under Canadian law. The corporation administers title to ICEL literary properties, which are administered on behalf of the Member Conferences.

ICEL's primary task is to provide the Member Conferences of Bishops with English translations of the Latin liturgical books of the Roman Rite.

The members of ICEL are eleven Bishop Representatives from Conferences that use English in the liturgy: Australia, Canada, England and Wales, India, Ireland, New Zealand, Pakistan, the Philippines, Scotland, Southern African, and the United States. The eleven Bishop Representatives also serve as the Board of Directors of the civil entity. There are also fifteen Associate-member Conferences of ICEL that have access to the English language liturgical texts and are invited to comment on draft texts.

In 2003, ICEL was given official recognition by the Holy See in the form of governing Statutes. The policies and procedures contained in the Statutes were revised in July 2011.

In September 2017, the Holy Father issued the motu proprio *Magnum Principium*. This legislation changed canon 838 of the Code of Canon Law, which pertains to the approval process of liturgical texts prepared by ICEL and submitted by the Conferences of Bishops to the Dicastery for Divine Worship and the Discipline of the Sacraments. Following this, in October 2021 the Congregation issued the decree *Postquam Summus Pontifex*, which "is intended to recall, interpret and amend norms and procedures regarding the publication of liturgical books in the various languages" (Introduction, no. 3).

As a result of the new legislation, the Bishops of the Commission revised the ICEL Statutes in accord with the needs of the Conferences and presented them to

the Presidents of the Member Conferences. By August 2023, all eleven Conferences had given their approval to the new document governing ICEL's work.

The ICEL program of translation is carried out under the authority of the Bishops of the Commission, and more directly by an Executive Committee of the Commission that meets monthly. Projects are carried out with the assistance of working groups of specialists, as well as individual translators, musicians, editors, and consultants. The work is coordinated by the staff of its permanent Secretariat, located in Washington, DC.

ICEL itself is not a publisher of liturgical books and related materials in the usual sense. Rather, like individual authors and translators, it provides the content of such publications to the Conferences of Bishops, who in turn authorize their publication within their territories. In administering the copyright of the English language liturgical texts, ICEL collects royalties from publishers of its work in the name of the Conferences of Bishops.

Liturgical Books

The Roman Missal

The English translation of the Third Edition of the *Missale Romanum* was put into use in the Member and Associate-member Conferences of ICEL in 2011 or shortly thereafter. That body of texts represents about one-third of the liturgical texts of the Roman Rite. Another third of the liturgical texts are contained in the Liturgy of the Hours, with the final third found in the nearly twenty ritual books that comprise the Roman Ritual and the Roman Pontifical.

The decree *Postquam Summus Pontifex*, mentioned above, included modifications to the General Instruction of the Roman Missal. A translation of the decree was provided to the Conferences in May 2022.

As noted in the previous ICEL Report, the Bishops of the Commission have discussed various suggestions for revisions to the Missal. Those conversations continued during the 2022 and 2023 meetings among the Bishops of ICEL, and also in correspondence with Conferences. As of this writing, no decision has been made as to whether revision work should begin, or, if it is to be undertaken, what its scope might be.

The Roman Ritual, Roman Pontifical, and Other Texts

The following texts have been issued by ICEL in Gray Book since the Roman Missal and before the current reporting period:

- The Order of Celebrating Matrimony
- The Order of Confirmation
- The Order of Dedication of a Church and an Altar
- Exorcisms and Related Supplications
- The Liturgy of the Hours, Supplement: 1984 to 2004
- Our Lord Jesus Christ, The Eternal High Priest
- The Order of Blessing of Oils
- The Order of Baptism of Children
- Roman Missal and Liturgy of the Hours, Supplement: 2014 to 2016
- Ordination of a Bishop, of Priests, and of Deacons
- The Order of Christian Initiation of Adults
- The Order of Penance
- Blessed Virgin Mary, Mother of the Church
- The Order of Anointing of the Sick and of their Pastoral Care
- Holy Communion and Worship of the Eucharistic Mystery outside Mass
- Liturgical Texts for Saint Paul VI
- Liturgical Texts for Our Lady of Loreto
- The Rite of Deputing Extraordinary Ministers

The liturgical texts that contain ministerial chants are set to music after the Gray Book has been issued to the Conferences. This music is then provided to Conferences for potential use in publications. The musical texts of the Roman Missal and a few other texts are also available on the ICEL website.

Translation work also progressed on remaining liturgical texts of the Roman Rite. During this reporting period, Gray Books have been issued for:

- Liturgical Texts for Saint Faustina Kowalska (August 2022)
- Order of Religious Profession (April 2023)
- Order of Blessing of an Abbot or an Abbess (April 2023)
- Order of Consecration of Virgins (April 2023)
- Order of Crowning an Image of the Blessed Virgin Mary (August 2023)
- Liturgical Texts for Doctors of the Church (August 2023)
- Liturgical Texts for Martha, Mary, and Lazarus (August 2023)
- *The Roman Martyrology* (October 2023)

In addition, during the period of this report translation work has continued on several texts: *The Institution of Lectors and Acolytes* had been issued in Green Book form in 2020 and the Commission had reworked the texts in preparation for a Gray Book. The ICEL Green Book for *The Institution of Catechists* was issued to Conferences in August 2022 and the Bishops revised the texts in light of comments in July 2023. It is expected that Gray Books for these three Institution texts will be issued in 2024.

Other liturgical texts of the Roman Rite that might see revision or retranslation in the coming years include: the *Lectionary for Mass*, the *Collection of Masses* and *Lectionary of the Blessed Virgin Mary*, the *Order of Christian Funerals*, the *Book of Blessings*, and the *Ceremonial of Bishops*.

The Liturgy of the Hours

The Report for 2001-2013 contained a detailed description of a revision of the ICEL translation of the *Liturgia Horarum*, and reports since then have provided details of the Green and Gray Books of various categories of material issued to Conferences.

In addition to the elements initially requested for this revision, the Bishops determined that other elements of the Liturgy of the Hours (namely: antiphons, responsories, Patristic or non-biblical readings, introductions to the Lord's Prayer, and hagiographical introductions) should be reviewed for possible revision, especially for the sake of consistency with the Roman Missal and other liturgical texts issued in recent years. This review was completed in 2022 and approved by the Bishops, and the additional material was provided to Conferences in May 2023.

The Bishops directed the Secretariat to assist the Conferences through the assembly of a Gray Book of the full manuscript of the Liturgy of the Hours in four volumes, and this is expected to be finished by late 2024 or early 2025.

The Roman Martyrology

In 2004, the *Martyrologium Romanum* was issued by the Holy See—the last major text of the Roman Rite to be promulgated following the reforms initiated by the Second Vatican Council. The ICEL Gray Book was issued to Conferences on 17 October 2023, the 60th Anniversary of ICEL's founding. Supplementary

material, such as the extensive indices of the book, are expected to be delivered to the Conferences in 2024.

The Dicastery for Divine Worship and the Discipline of the Sacraments

With the Holy Father's apostolic constitution *Praedicate Evangelium* of 19 March 2022, the Congregation assumed its current name of Dicastery for Divine Worship and the Discipline of the Sacraments.

During the Consistory of 27 August 2022 the Holy Father elevated H.E. Arthur Roche, Prefect of the Dicastery, as Cardinal of the Holy Roman Church and appointed him Cardinal-Deacon of San Saba.

The ICEL Statutes stipulate the need for regular communication between ICEL and the Dicastery, and to facilitate this goal a Delegate appointed by the Dicastery is invited to all meetings of the Commission. Msgr Andrew Wadsworth, then Executive Director of ICEL, met with members of the Dicastery in Rome in October 2022 to discuss various projects.

Meetings

The Commission

During the period of this report, the ICEL Bishops met three times; in July 2022, then in February and July of 2023. All three meetings were held in Washington, DC.

The ICEL Bishops met at the Commission's Secretariat from 18 to 22 July 2022 and in the course of their work approved the Gray Books for Saint Faustina Kowalska and Institution of Lectors and Acolytes. They also approved Green Books for Doctors of the Church, Saints Martha, Mary, and Lazarus, and the Institution of Catechists.

In light of *Magnum Principium* and in response to *Postquam Summus Pontifex*, the Bishops revised the ICEL Statutes in cooperation with the Dicastery for Divine Worship and the Discipline of the Sacraments. Following the meeting, the revised Statutes were circulated to the Presidents of Member Conferences.

The Commission began to discuss ways in which it could respond to calls from several Conferences for a revision of some or all of the Roman Missal, while acknowledging that other Conferences did not feel that a revision was warranted. As a first step, the Bishops decided to commission a review of a selection of the Missal's orations.

The election of officers took place at the meeting of the Board. Bishop Hugh Gilbert was re-elected Chairman, Archbishop Patrick O'Regan was re-elected Vice-Chairman, Bishop Alan McGuckian was elected Secretary, and Archbishop Brian Dunn was re-elected Treasurer.

The ICEL Bishops next met from 30 January to 3 February 2023. The Bishops reviewed texts and responded to suggested alterations in the Green Books for rites related to religious life (Religious Profession, Blessing of an Abbot or Abbess, Consecration of Virgins). The Bishops also received comments from Conferences on the Roman Martyrology, but decided to refer these questions to the subcommittee that had done extensive work in the preparation of the manuscript.

The Bishops received a report on the Advent orations of the Roman Missal, prepared by a study group. The report highlighted both positive and negative aspects of the current translation, and the Bishops agreed to continue to discuss the matter in future meetings.

Msgr Andrew Wadsworth announced his intention to resign from ICEL later in the year, and agreed to assist the Bishops in finding candidates to fill the position of Executive Director.

The Bishops next met from 17 to 21 July 2023 and reviewed comments on Crowning an Image of the Blessed Virgin Mary and the Roman Martyrology. These texts were approved for issuance as Gray Books. They also approved Gray Books for Doctors of the Church, Saints Martha, Mary, and Lazarus, and the Institution of Catechists. The Bishops decided that the latter text should be held until work on the rites for Institution of Lectors and Acolytes was completed, but the others were issued to the Conferences.

The Bishops interviewed three candidates for the position of Executive Director to replace Msgr Andrew Wadsworth, who had served since 2009. The

Commission appointed Fr. Andrew Menke to a five-year term as Executive Director, beginning 1 November 2023.

Msgr Wadsworth will remain a consultant to the Commission and Director of the St Gregory Institute for the Study of Liturgical Latin, which is a collaborative project between ICEL and the Department of Greek and Latin at the Catholic University of America.

The Commission received the votes of Member Conferences on the draft text of revised ICEL Statutes, which had been circulated to the Conferences the previous year. The Statutes gained the necessary two-thirds threshold for approval. No Conference voted against them, one offered suggestions for a slight modification, and one had not yet voted at the time of the meeting.

Editorial Committee

According to the procedures for translation outlined in the ICEL Statutes, the Editorial Committee was established to provide an in-depth evaluation of the base translations of Latin liturgical texts for submission to the Bishops of the Commission for their consideration. The members possess specialized skills in ecclesial Latin and the liturgical rites. Their deliberations on the texts are guided by directives of the Second Vatican Council, the Code of Canon Law, and the relevant principles, norms, and directives of the Holy See and the sponsoring Conferences of Bishops.

The present members of the committee are:

A subcommittee of the Editorial Committee, under the chairmanship of Archbishop Leo Cushley, met in the Secretariat in April 2022 to evaluate translations of Doctors of the Church, Saints Martha, Mary, and Lazarus, and the Institution of Catechists. The full Editorial Committee met in the ICEL Secretariat in October 2022 to evaluate and refine a new base translation of the *Ordo Exsequiarum*. And another Subcommittee under the chairmanship of Bishop Michael Campbell met in the Secretariat in March and May 2023 to incorporate comments and finalize texts for the Roman Martyrology.

The ICEL Secretariat

As mentioned above, Fr. Andrew Menke was appointed as the eighth Executive Director of the ICEL Secretariat, beginning 1 November 2023. Fr Menke is a priest of the Diocese of Lincoln, Nebraska, and until recently was Executive Director of the Secretariat for Divine Worship of the United States Conference of Catholic Bishops, a post he held since 2017. He holds a license and a doctorate in Sacred Liturgy from the Pontifical Liturgical Institute, Sant'Anselmo, Rome. He was also an official of the Dicastery for Divine Worship and the Discipline of the Sacraments from 2010-2015.

The Commission thanks Msgr Wadsworth for his years of service (2009-2023) as Executive Director, during which time twenty-six separate liturgical texts have been issued to the Conferences, and multiple fascicles of material for the revision of the Liturgy of the Hours. Msgr Wadsworth will remain a part-time employee as Director of the St Gregory Institute for the Study of Liturgical Latin. The Institute is presently engaged in producing a multi-volume collection of commentary on the Hymns of the Liturgy of the Hours, as well as hosting annual lectures and graduate seminars at the Catholic University of America.

Remembrance

Former Bishop Representatives

Dr. Raymond Lahey, former Bishop of Antigonish, was the Representative of Canada at the January 2009 meeting of the Commission and previously served on the Consultants' Committee as well as the Original Texts subcommittee. He resigned in 2009, was laicized in 2012, and died on 10 April 2022.

Archbishop Mario Conti, emeritus of Aberdeen and Glasgow and Scottish Representative from 1978 to 1987, died on 8 November 2022.

Bishop Martin Drennan of Galway, the Irish Representative from 2012 to 2016, died on 26 November 2022.

Bishop Maurice Taylor of Galloway, was the Scottish Representative from 1989 and Chairman 2002-2012, died 14 June 2023. Bishop Taylor was elected Chairman at a time of great transition in the work and organization of ICEL. Several projects, including a revised translation of the *Missale Romanum* were coming to completion just as the Holy See began to issue new guidance on

liturgical translation. Through meetings and teleconferences with the members of the Board and the Presidents of Conferences, Bishop Taylor strove to promote the work of the Commission. An account of this period of ICEL's history is included in his book *It's the Eucharist, Thank God*.

The Holy See

Cardinal George Pell, former Archbishop of Melbourne and Sydney, Australia, died on 10 January 2023. Cardinal Pell was Chairman of the Vox Clara Committee from its first meeting in April 2002 until 2017. The Committee was established to advise the Dicastery in its responsibilities related to the translation of liturgical texts in the English language and to strengthen effective cooperation with the Conferences of Bishops.

Archbishop Geraldo Majella Agnelo, Secretary of the Congregation for Divine Worship and the Discipline of the Sacraments from September 1991 to January 1999, died on 26 August 2023.

ICEL Consultants

The Rev. Jacob Theckanath, a member of the Advisory Committee from 1986 to 1992, died on 28 November 2021. Fr Theckanath was director of the National Biblical, Catechetical, and Liturgical Centre (NBCLC) in Bangalore, India for ten years and the Secretary for Liturgy (CCBI) in India.

Mr. Michael Hodgetts (England), a member of the Translations and Revisions subcommittee through the 1980s and a base translator until 2003, died 12 December 2022.

Dr. J. Frank Henderson (Canada), a member of the Advisory Committee from 1980 to 1987, the Translations and Revisions Subcommittee and the Discriminatory Language subcommittee, the latter two he chaired, died on 28 January 2023.

The Most Rev. Marcel Gervais, Archbishop Emeritus of Ottawa, a member of the Advisory Committee from 1974 to 1978, died 6 August 2023.

The Rev. Msgr. Joseph L. Cunningham, priest of Brooklyn NY, a member of the Advisory Committee from 1973 to 1985, died 12 October 2023.

Finances

As stated at the outset of this report, ICEL is an association of Bishops designated by the sponsoring Conferences of Bishops. The Board of Directors (the representatives of the Conferences) has financial oversight of the Corporation and elects a Treasurer from their membership to govern the financial activities.

The Executive Director, under supervision of the Treasurer and the Executive Committee, carries out the day-to-day functions of ICEL and has direct financial control of the Corporation. He is assisted by an accountant on staff and periodic advice from an independent auditing firm (Rogers and Company) which prepares an annual audit.

In 2013, the ICEL Treasurer established an Advisory Committee of professionals to offer advice on ICEL's investments, review the annual audit, and review other financial statements provided throughout the year. The Committee meets quarterly to offer advice to the Commission.

After the initial grants or contributions made by the sponsoring Conferences of Bishops in 1964 and 1965, the principal source of revenue for ICEL has been royalties received from the publishers of editions that contain material prepared and copyrighted by ICEL.

ICEL was able to repay the initial contributions of the Conferences by the early 1970s. During the 1980s, ICEL had a secure financial position and was able to make distributions of funds to the Member Conferences, in proportion to their original contributions. However, expenses increased from 1993 to 2003, and the Conferences of Bishops generously helped subsidize ICEL's work.

Following the publication of the Third Edition of the Roman Missal in 2011, royalty income began once again to increase. The ICEL Bishops therefore voted to distribute funds to the Conferences from 2013 through 2016, and in 2018, 2021, and 2023. With the final distribution, the amount that had been received in subsidies from 1993 to 2003 has been repaid.

Currently, ICEL is on solid financial footing. With the assistance of the Advisory Committee, the Commission strives to maintain a good stewardship of its resources.

ICEL materials are made available to publishers, through the National Conferences, without distinction on a non-exclusive basis, subject only to the

condition that the respective Conference gives permission for the publication or distribution of the material in its territory.

As a nonprofit body at the service of the Church in the countries where English is spoken, ICEL endeavors to conduct its program on a self-supporting basis with just remuneration for translators, editors, composers, consultants, and staff, and with expenditures directly related to its projects.

ICEL does not own property other than necessary office furnishings and equipment, and the literary and music property that is held for the use of the Church. A limited reserve beyond current needs is maintained to provide for the continuance of the work and as protection against fluctuations in royalty revenue and infringement of texts. And, as stipulated in the ICEL Statutes, the reserve is held in the name of the sponsoring Conferences of Bishops, who wholly own and operate ICEL in service to the Church.

Most of this reserve is held in investment accounts. Due to banking regulations, it is required that these accounts be owned by a US entity, so in 2020, ICEL established "the ICEL Foundation," a parent company for the International Commission on English in the Liturgy. As a result of this process, ICEL is listed under the Archdiocese of Washington in the Official Catholic Directory published by P. J. Kennedy & Sons.

Each year, typically in June, following the audit of ICEL's financial records, an audited report is made available to the Conferences of Bishops through the ICEL representative on the Board of Directors. The treasurers and other officers of the sponsoring and participating Conferences of Bishops to which this report is directed are invited to request further information directly from the ICEL Secretariat.
